In Attendance

SEB members attended the final business meeting; thus met the quorum (35).

Call to Order - Oscar Liburd, President, SEB-ESA

Oscar Liburd called the meeting to order. He welcomed everyone to the final business meeting.

Reading of 2018 Meeting Minutes - Amanda Hodges

A motion was made and seconded to dispense with the reading of the minutes. The motion to dispense with the reading of the minutes was passed unanimously.

Financial Report - Amanda Hodges, Secretary-Treasurer

Net worth

Net worth

As of 31 January 2019, SEB has a net worth of \$91,530.72, maintained as cash in two accounts with PNC Bank, and as reserve funds in the Branch/Section/Foundation A new checking account at PNC replaced the former checking account in December of 2018. Investment Fund managed by TIAA-CREF. The net worth was \$2,134.80 higher than the balance of \$89,395.92 on 31 January 2018. The net worth remains \$12,973.26 lower than the balance of \$104,503.98 on 31 January 2017.

Incomes and Expenditures – 2018 Orlando meeting (covered under the 2017-2018 budget)

Cash flow summary of the 2018 SEB annual meeting held in Orlando, FL is presented as Appendix A. SEB collected \$38,385 in registration fees, and \$7,975 in sponsorship during the meeting. Additional incomes include \$800 from the Gast and Hays Awards Funds, \$10,585 in Program Enhancement Funds from ESA, and \$2,000 in supplemental funding to the Linnaean teams representing SEB at the national meeting in Vancouver, CA. The total income for the meeting was \$59,745.

The total expenditure of the Orlando meeting was \$63,498. The Local Arrangements Committee incurred the largest amount of expenditures in providing meeting space, audiovisual equipment, food and beverages to meeting attendees, totaling \$48,421.70. As in previous years, expenditures for breaks, luncheon, reception and AV were over budget.

Most other committees and offices stayed within their respective budgets. which was covered by supplemental funding from ESA.

SEB netted a loss of \$3,753 from the 2018 annual meeting in Orlando, FL. Comparatively to the 2017 annual meeting in Memphis, TN, the loss was \$686 less as the prior meeting netted a loss of \$4,439.03.

Proposed Budget for 2019-2020

The total proposed budget for the 2019-2020 is similar to the approved budget for 2018-2019 (Appendix B).

The proposed budget for most committees and offices remained the same as the 2019-2020 budget, except for the addition of funding for the Early Career Professional Lunch and Learn. Budget increases were also provided for A/V as A/V expenditures in the last several years have been overbudget in terms of actual expenditures. The anticipated sponsorship for the conference was reduced to resemble actual sponsorship obtained during the 2017-2018 and 2018-2019 meeting cycles.

An increase in registration rates was approved by the Executive Committee for the 2019 meeting in Mobile, AL. Increased registration revenues are anticipated for the 2020 meeting in Atlanta, GA. Increased registration revenues are also anticipated through the addition of meeting attendees as the conference will represent a joint meeting between the SEB and EB of the ESA.

The proposed budget for 2019-2020 achieves a balance of income and expenditures.

Auditing Committee Report -Adam Dale

Committee members included Mark Abney and former Secretary-Treasurer, JC Chong. The books were all in order and all receipts matched expenses. A motion passed unanimously to accept the audit report.

Proposed Budget-Amanda Hodges

The proposed budget was presented to the membership as it was discussed with the Executive Committee. The membership approved the proposed budget, and the meeting discussion focused on sponsorships in order to avoid future meeting deficits. A motion passed unanimously to accept the proposed budget.

Committee Reports

Local Arrangement Committee Report-David Held

Committee members:

David Held, Chair Lawrence Fudd Graham Kelly Palmer Arthur Appel

Actions by the Committee:

- The SEB meeting in downtown Mobile overlaps with the city's Mardi Gras celebrations. The local tourism bureau expects 100,000-150,000 visitors to downtown Mobile specifically for Mardi Gras.
- A site visit was conducted at the Renaissance Mobile in October 2018 by the President and the LA Chair. We met with our site contact, Eileen Serrano, and went over details of the contract, and toured the facilities.
- There were early issues with SEB attendees scheduling and room assignments. The LA Chair visited the hotel in Jan to meet in person with the hotel management about the housing issue. Regarding scheduling, the hotel acknowledged the issues were partly corporate and also due to the hotel being sold out for Thursday and Friday before the meeting. Attendees trying to schedule these dates as part of their stay were receiving messages that no rooms were available. There was concern that this may drive attendees to other hotels which would affect our room block and attrition. The LAC worked with ESA headquarters staff to update the SEB website with timely information about housing.
- In late Jan, the room block at the Renaissance was sold out and is currently at 101% (383 room nights) capacity. The LA chair worked with Conference Direct and ESA headquarters to distribute a solicitation for proposals for an alternate housing venue. The Admiral Hotel, downtown Mobile, submitted a courtesy block proposal which was signed by the LA Chair. The Admiral is just down the street about 4 blocks from the Renaissance. The SEB webpage was updated 4 Feb with this new housing information. This proposal contained no attrition clause, but rooms were

- more expensive than the conference hotel. The cost increase was due to limited hotel rooms in downtown for Mardi Gras. There are currently 48 room nights booked at the Admiral.
- The LAC worked with the Program Committee and the Renaissance to accommodate the logistics for the MS Bug Blues Outreach Program. This will be a one-day event held on-site coincident with the SEB.
- The LAC developed the menu for the meals, breaks, and Monday evening reception for the meeting. The F&B was discussed with the Executive Team and adjustments were made. It was decided to wait until after the registration deadline to finalize these details with the hotel.
- Final approval of the AV budget was determined to be at the discretion of the LAC.
- At the request of President Liburd, the LA Chair secured President of Visit Mobile to provide a welcome and some remarks about the city at the opening session of the meeting.
- The LA Committee accepted responsibility to have signs acknowledging corporate sponsorship of the meeting made. These signs will be displayed at breaks, meals and the Monday evening reception.
- The LAC is working on securing laptops needed for this event, mainly through support provided by the AL Cooperative Extension System. Thanks to ACES for their support of the SEB meeting.
- The LAC worked with headquarters to update the 'need to know before you go' information. This provides important information on parking and parade schedules in downtown Mobile that could affect travel.
- The LAC coordinated with the groups meeting on the shoulder dates (Sunday and Wednesday) of the meeting. They had specific needs for their groups and the LAC worked with them on AV needs, and connected them with Eileen Serrano for food service.
- Student Entomology Clubs within the SEB contacted for the LA Chair about displaying Club information and items for sale at the meeting. The LAC has a list of these groups and tables will be placed in the poster area for them.

Program Committee - Ayanava Majumdar

- Rebecca Schmidt remained program chair until Dec 2018. Ayanava Majumdar carried on building and editing the program and working with ESA staff from January 2019.
- Ayanava got a price estimate for publishing the program book from Allegra Printing in Auburn, AL. The cost estimate (based on 2017 book with color pages) was communicated to the entire SEB team during committee meetings.
- Worked with David Held to change meeting rooms several times. Don't have specifics on that.
- Tentative status of program: 10 symposia, 75 student talks, 44 student posters, 25 submitted talks, and 34 submitted posters (see changes below).

Three members of the committee are ending their term this March. We have recruited members to represent Georgia, Florida and Louisiana. This includes also a new Chair for the committee.

Our mission is the recruitment of new members into the society and to ensure that the society provides valuable services to its members.

Membership in SEB as of Jan 2019: 1,126 (22% of ESA membership: 5,038), broken out as follows in the table (attached).

Overall, many branch members have not renewed for 2019 yet. This membership decline probably is due to the fact that some members wait until they can register for the annual meeting (June/July) to renew their memberships.

Member Awards Committee - David Buntin

The call for nominations went out in Mid-October with an original closing date of December 12, 2018. Due to lack of submission the closing date was extended to January 7, 2019. The Member Awards committee met via email to consider nominees for the branch awards. The number of nominations was similar to the previous year, but most awards only had one or no nominees. No nominations were received for the Southeastern Branch Distinguished Achievement Award in Extension, Southeastern Branch Distinguished Achievement Award in Teaching, Southeastern Branch Distinguished Achievement Award in Horticultural Entomology, and Southeastern Branch Distinguished Service to the Certification Program Award.

Revised award scoring spreadsheet was created for a couple of the awards which should be added to the SEB guidelines

document. Three committee member terms expire in 2018, and two or three new members are needed to serve through 2022.

Student Awards Committee - Hugh Smith

Kirby Hays

Kelly Murray-Stoker grew up in Tifton, GA and realized an interest in scientific research after summers during high school spent working on the University of Georgia Tifton campus. She attended the University of Georgia, majoring in both Entomology and Ecology with a minor in Geology. Kelly conducted undergraduate research on a species of caddisfly in Trinidad in the context of changing steam fish communities. She graduated in 2014, then spent time working as a stream ecology technician for the Georgia Department of Natural Resources. She was able to combine her interests in stream ecology and entomology during her Masters program at UGA. Her thesis research focused on long-term change in aquatic insect communities of the Ogeechee River, which was made possible by sampling conducted in the 1980s. During her Masters, she was also able to explore an interest in Trichoptera taxonomy by participating in a collecting trip to Vietnam with researchers from Clemson University. Kelly hopes to continue to study caddisfly systematics and ecology in a PhD program in the near future.

Comstock

Dr. Zachary DeVries (Southeastern Branch) received his Ph.D. in Entomology from North Carolina State University under the direction of Dr. Coby Schal. Zach received both his bachelor's degree in Zoology and Master's degree in Entomology from Auburn University, where he developed a passion for working with urban pests (e.g. cockroaches, bed bugs, etc.). His dissertation research focused on several aspects of urban pest behavior, physiology, evolution, and management. Specifically, he evaluated the efficacy and exposure risks associated with total release foggers ("bug bombs") used for German cockroach control. In addition, he evaluated bed bug host-attraction and several behavioral and physiological factors responsible for preventing gene flow among different host-associated lineages (human- and bat-associated) of bed bugs. During his graduate tenure, Zach received numerous national and international level awards for his work relating to insect behavior, physiology, and integrated pest management (IPM). He has also taught several undergraduate entomology courses and has actively engaged the public in both extension and outreach activities throughout his career, including events such as BugFest and pest control association meetings. Zach is currently a postdoctoral research scholar at North Carolina State University, working with Dr. Coby Schal on the relationship among urban pest biology, management, and human health.

Numerous volunteers assisted with judging the student competition at the 2019 meeting, and Dr. Hugh Smith recognized the contribution of the student awards committee members and volunteers who assisted with judging and the completion of a successful student competition.

- 1. **ESA 2018 Annual Meeting in Vancouver, BC.** ESA, ESC, ESBS Joint Annual Meeting in Vancouver, BC was a productive and well attended meeting. The student events observed a great turnout and we enjoyed the collaboration with ESC and ESBC to make these events a success. **a. The ESA Governing Board meets twice each year, in June to preview the annual meeting site, and in November, during the annual meeting. In addition, the Governing Board visits by conference call in September and April to discuss issues. During the past year, the Governing Board approved the following actions.

ESA Bylaws and Policies

• Approved proposed Bylaws changes and the development of a Society Policy Manual for greater flexibility. Bylaws changes still require full membership votes to change. Society Policies require a majority vote by the governing board.

- Approved transition process for replacement of Executive Director position when need arises.
- Privacy Statement for the Entomological Society of America (Effective Date: January 22, 2019)
- Voted to unify ESA policy on harassment and scientific misconduct and tasked the Committee on Ethics and Rules with developing appropriate policy language to this effect

ESA Budget

- Annual meeting registration, exhibits, and investments above budget, offsetting reduced OUP royalty and career center/website revenues. Positive net income for 2017.
- Deficit budget for 2018 due to conservative OUP royalties. Implementing costsaving measures.
- Strategic reserves remain strong enough to provide interest income to offset short term deficits. Motion to use up to 3% of annual interest income to close budget deficits approved.
- Approved ESA participation and funding for the 2018 March for Science
- Approved 2018 budget
- Approved compensation package for ESA staff

ESA Journal Income

- Long term trends in publishing will continue to pressure the revenue that ESA earns from its portfolio of journals
- We continued to see a shortfall in OUP payments due to a drop in subscriptions and shortfall in open access projections
- OUP has significantly increased international institutional subscriptions to ESA journals, such that realized payments are substantially higher than the guaranteed contract rate and should approach the projected payment after a short delay.
- Current situation would result in a \$400,000 shortfall in 2024 when the OUP guaranteed payment ends. What actions should we take to buffer budget from this shortfall?
- Established Publications Task Force to consider changes in journal management and financing. Plans are needed for new strategies to adapt to these developments.
 Fortunately, we have some time to explore options and make necessary adjustments.

Financial Projection Models for ESA Journals

- Reinstate page charges at rates varying from \$30 to \$90 per page (net benefit)
- Move papers from print journals to open access journals (little change to net cost).
- The best return to ESA, covering about \$200,000 of projected shortfall, would come from reinstating page charges at \$90 per page.
- Will do listening sessions to see how members view options for dealing with revenue shortfall.

ESA Journal Authors Survey Results

- Peer review is a critical element (bad experiences with an editor can discourage submissions for years).
- ESA has a reputation for slow peer review and publication (but this has improved significantly in recent years).
- Impact factor is a key decision factor for submission (ESA journals all are in top 15 for ESA authors, including #2 and #3, but PLoS ONE is top journal by 2-fold and the biggest competitor for ESA authors).

ESA Journal Approved Recommendations

- Position *Annals* to be top ESA journal by limiting acceptance, transferring general interest papers to *Annals*, transferring more focused papers to other journals.
- Institute EIC search process, term limits and evaluation.
- Task EICs with revising scope for each journal to give authors clearer direction.
- Establish Editorial Board for each journal to maintain consistency and track metrics.
- Complete peer review within 35 days.
- Improve support and recognition for peer reviewers.

Journal Editors

- Approved Frank Zalom and Eric Rebeck as EICs for *Journal of Economic Entomology* and *Journal of Integrated Pest Management*, respectively
- Re-appointment of Dr. William K. Reisen to a second term as editor-in-chief of the Journal of Medical Entomology
- Extension of Jim Whitfield and Sydney Cameron's terms as co-editors-in-chief of Insect Systematics and Diversity by two years, to 2021.

Publications Council

- Clarify duties of Publication Council.
- Motion: Move to add one elected representative from each Section to the new Publications Council. Motion carries.

Entomological Foundation

- Tim Schowalter appointed to the Entomological Foundation Board of Directors for a term of 3 years
- On the advice of its auditors, the Board of Directors for the Entomological Foundation voted in November to investigate the dissolution of the Foundation and the movement of all viable programs to the ESA Education and Outreach Committee (EOC).

ESA Certification Corporation

- Approved Certification Corp report and budget.
- Fueled by the CDC contract to train more Medical-Veterinary entomologists, the BCE program is expected to slightly surpass annual goals
- ACE program is expected to fall slightly below goals, though still realize overall growth of more than 6%

Science Policy

- Supported the 2017 March for Science and approved participation and funding for 2018 March
- Approved a fourth class of Science Policy Fellows. There is a need to encourage diversity of nominees.
- Approved science policy statements on arthropod biodiversity and fact sheet on Bt food safety
- Position statement on Global Climate Change approved (January 25, 2019).
- Statement in progress: Importance of genetic research; tick-borne diseases; pollinator health (updates)
- Lewis Burke and our Science Policy Fellows are promoting ESA interests in Washington.
- Lewis-Burke Associates is using our science policy statements to advise legislators and agencies.
- At ESA 2018 Erin Cadwalader and Ben Kallen, representatives of Lewis Burke Associates, discussed the outlook in Washington for the next year given recent election results and administration policy Cuts to science funding by federal agencies likely to continue.
- A motion to reappoint Allan Felsot to continue as the Society's EPA Liaison was made and carried.
- Farm Bill includes language taken directly from ESA, an unprecedented achievement for ESA

Diversity and Inclusion

- Motion Approved: Approve and implement the draft Professional Conduct Disclosure form for nominees for all ESA honors, awards, and governance positions for 2019 or as soon as allowed by current planning cycles.
- Requested data for discussion related to a request from the Early Career Professionals Committee to pursue a bylaws change to add an early-career representative to the Governing Board.
- Discussed a zero tolerance policy for professional misconduct, including sexual harassment, wherever it occurs.
- Exploring legal protocols for investigation, response to complaints and penalties.
- Everyone deserves a safe workplace and safe meetings.
- Also discussed statements from SysEB Section, the Student Affairs Committee, and the Early Career Professionals Committee in response to racist statements in the "Scarabs" newsletter
- Established a task force to explore renaming the Linnaean Games, given concerns about honoring Linnaeus would, by extension, honor his racist views. Feedback from members was collected. Draft recommendations to retain the name are open for comment until April 25th. "The Games do not celebrate Linnaeus's views, but acknowledge his role in science. Rather than dropping the name and risk forgetting the issue, this is an opportunity to teach about racism in science and how it inhibits progress. The task force suggests that emphasizing the Games' traditions and history

should be accompanied by highlighting the contributions of historically underrepresented scientists and bringing attention to the effects of historical racism in science. As the Games move forward, the task force also recommends using the Games to heighten community-building and inclusion among all students, particularly students from historically underrepresented groups."
